The Vice-Rector in charge of the School of Social Sciences at Adam Mickiewicz University in Poznań announces a competition for one position of assistant professor in the group of teaching staff at the Faculty of Law and Administration, in the Department of Economic Sciences.

## III. Requirments and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2024, item 1571, Article 113 as amended) and who meet the following requirements:

- 1. A doctoral degree (PhD) in economic sciences;
- 2. Documented expertise in the field of economics and management, particularly marketing, supported by scientific publications;
- 3. Authorship of recent publications that are utilized into teaching activities;
- 4. Competence and experience in teaching academic-level courses in economics and management, especially marketing;
- 5. Experience in organizational work, in business practice and the popularization of scientific knowledge.

Candidates who do not have at least 5 years of teaching experience at the academic level in the field of economics and management, particularly marketing, or professional experience in business practice will not be admitted to the interview stage.

## VIII. The selection process

- 1. Competition committee begins working no later than 14 days after the deadline for submission of documents.
- 2. Formal evaluation of submitted proposals.
- 3. Call to provide additional or missing documents if necessary.

- 4. Selection of candidates for the interview stage.
- 5. Interviews for candidates who meet the formal requirements.
- 6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.
- 7. The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.
