II) Job Offer description

Assistant Professor at the Institute of Film, Media and Audiovisual Arts, WFPiK. The employer expects to conduct research in the humanities (oriented towards film studies), to apply for scientific grants, to publish articles and monographs, to teach, including workshops using audiovisual tools. The employer expects a commitment to organisational work (of an academic nature, such as conferences, and of an administrative nature, such as activities in various institute and departmental committees and bodies) and popularisation.

III) Requirments and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2023, item 742) and who meet the following requirements:

- 1. Completed studies in the field of film studies (bachelor's and / or master's studies), doctoral degree in the humanities in the field of art studies or culture studies or literature.
- 2. Documented scientific, didactic and organizational achievements.
- 3. Certificate of congressional language proficiency or the candidate's own declaration of the knowledge of the congressional language with a declared level of fluency in speech and writing and the readiness to prepare conference presentations and publishing post-conference materials in this language.

In justified cases, the committee reserves the right to request additional external reviews of the candidates' achievements and / or additional documents to assess the candidates' qualifications.

V) Required research, teaching or mixed experience

The candidates' scientific, organizational and teaching achievements will be assessed proportionally to the time of their professional activity. The Commission is keen on achievements in research and teaching relating to audiovisual culture and films in particular.

There is a strong emphasis on practical skills in the use of audiovisual technology: camera skills, video and audio editing.

VII) Eligibility criteria

- 1. Scientific achievements: publications (monographs and peer-reviewed articles, editorials and co-editions, translations from English or other foreign languages), participation in national and international conferences (with paper), grants (leader, contractor), current membership in editorial committees of journals and publishing series, foreign and national scientific internships (place, type of internship, aims, results), awards for scientific activities.
- 2. ability to use audio-visual technology in practice: use of camera, video and audio editor.
- 3. experience in conducting workshops using video and audio recording and editing equipment.
- 4. organisational activities: organisation of conferences and events of a scientific and cultural nature.
- 5. cooperation with national and international centres and institutions.
- 6. teaching activities: teaching activities (type of classes conducted, topics and content of education, list of classes conducted in foreign languages), development of study programmes/specialisations, awards for teaching activities.
- 7. plans for further scientific and didactic development.
- 8. popularisation activities: popular science publications, organisation and conduct of events popularising media culture.

VIII) The selection process

- 1. Competition committee begins working no later than 14 days after the deadline for submission of documents.
- 2. Formal evaluation of submitted proposals.
- 3. Call to provide additional or missing documents if necessary.
- 4. Selection of candidates for the interview stage (from among persons meeting the formal requirements).
- 5. Interviews for candidates who meet the formal requirements. During the interview, the candidate may be asked to answer 1 question in English.
- 6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.
- 7. The Commission may ask for additional documents.

- 8. Candidates invited to the interview may be asked by the Commission to give a fifteenminute presentation on a scientific problem of their choice.
- 9. The chair of the competition committee announces the results and informs the candidates. This information will include justification. Submitted documents will be sent back to candidates.

IX) Prospects for professional development

Employment in one of the best Polish institutes focused on film and game studies is an optimal path of development for a scholar. An assistant professor is in constant contact with all research and didactic employees at the Faculty of Polish and Classical Philology, participates in the academic life of the Faculty, Institutes and Departments. The employee has a possibility to work in research teams and consult the progress of their own research at scientific meetings and conferences organized at the Institute of Film, Media and Audiovisual Arts and at other institutes. The assistant professor can be supported with the preparation and administration of research grant projects, may apply for funding or cofunding of their own research publications and participation in domestic as well as international conferences. They may also undertake research initiatives on their own and organize scientific conferences. The newly employed assistant professor is expected to receive a post-doctoral degree and become a professor. All together: research, teaching and organizational work at the Institute of Film, Media and Audiovisual Arts enable to get the necessary competencies, achievements, experience and authority to begin making efforts to obtain the degree of professor. The habilitation procedure is fully financed by the Faculty of Polish and Classical Philology.
