- Diplomas or certificates issued by colleges and universities attesting to education and degrees or titles held.
- Research statement including research plans;
- Teaching statement including teaching experience;
- Description of organizational experience;
- 2 recommendation letters;
- Consent to the processing of personal data as follows : *In accordance with Article 6 (1) (a) of the General Data Protection Regulation of 27 April 2016. III) Requirements and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2023, item 742, i.e. Article 113) and who meet the following requirements:

1. Doctoral degree in computer science;
2. Publication achievements adequate to the stage of a scientific career in computer science discipline;
3. Competence to teach academic-level IT subjects, in particular in the field of IT teaching, and practical competences related to experience in conducting workshops and trainings for teachers and school level students;
4. Motivation to work in science, independence, communication skills;
5. Motivation and teaching abilities;
6. Meeting the language requirements.

IV) Required languages

Language: English Level: fluent (at least B2 level), allowing for writing scientific publications and delivering conference presentations

Language: Polish Level: native or fluent, allowing the fulfillment of organizational and teaching duties

VII) Eligibility criteria

Detailed criteria for the evaluation of candidates (the candidate must receive at least 8 points):

1. Value of scientific achievements and scope of research topics (0-3 points),
2. Relevance of the issues and research for the scientific development of the Faculty (0-2 points);
3. Experience in teaching in the field of computer science at the academic level (0-2 points);
4. Competence to teach academic-level IT subjects and experience in conducting workshops and trainings for teachers and school level students (0-4 points);
5. Research plan (0-3 points).

VIII) The selection process

1. Recruitment committee begins working no later than 14 days after the deadline for submission of documents.
2. Formal evaluation of submitted proposals.
3. Call to provide additional or missing documents if necessary.
4. Interviews with candidates who meet the formal requirements.
5. The chair of the recruitment committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.

IX) Prospects for professional development

Work in a dynamic and diverse research environment; the possibility of applying for academic promotion (another academic degree and title).
