



PhD student position

We are seeking a curious and persistent <u>PhD student</u> to join the Zebrafish developmental neurobiology research group led by Dr Savani Anbalagan at the Adam Mickiewicz University, Poznań, Poland, supported by NCN Sonata-BIS project no UMO-2020/38/E/NZ3/00090.

Astrocyte cells are one of the major players in nervous system development and functioning. Neurohypophyseal (posterior pituitary) glial pituicytes are astrocyte-like cells that promote local axonal and vascular morphogenesis, and enable the release of neuropeptides Oxytocin and Vasopressin into the peripheral circulation. Our group studies the role of glial pituicyte-derived paracrine signaling molecules that regulate neurohypophyseal morphogenesis using zebrafish as vertebrate organism.

The project will take advantage of the genetic amenability of zebrafish and optical transparency to understand how glial pituicyte-derived factors regulate axonal morphogenesis. Using our recently developed CRISPR mutants and by generating novel transgenic fish lines, we will study how pituicytes regulate axonal morphogenesis. We will use advanced light microscopy techniques to characterize the phenotypes.

- Master's degree in a life science field (biology, biotechnology or related)
- Practical experience in zebrafish research, molecular biology techniques and confocal microscopy.
- Oral and written proficiency in English.

- Supportive environment, monthly stipend: 2 159,00 zł for 3 months (with possibility to be extended up to 24 months)
- Access to state-of-the art facilities
