#### II) Job offer description

The position of an assistant professor in a team of research-and-teaching staff working in the area of Finnish linguistics at the Department of Hungarian and Finnish Studies at the Institute of Applied Linguistics at the Faculty of Modern Languages and Literatures. The candidate will be expected to do research, be active in publishing and obtaining research grants, and teach students (210 hours per academic year).

#### III) Requirments and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2023, item 742) and who meet the following requirements:

- 1. A PhD in humanities.
- 2. Specialization in Finnish linguistics.
- 3. Ability to udertake the full-time position of adjunct.
- 4. Perfect and certified knowledge of the Finnish language and readiness for the verification proces for competency in the Finnish language.
- 5. Professional experience relevant to the duties of an academic teacher conducting lessons in a foreign language.
- 6. International activity, scientific and didactic cooperation with academic institutions abroad.
- 7. Good knowledge of the English language.
- 8. Proven scientific and research activity in linguistics, including highly regarded publications, grants or applications;

(The candidates are expected to fulfil the following requirements: 1) at least 2 papers published in journals from the list of Ministry of Science and Higher Education, with at least 10 points or one paper from A list of ministry or monograph (other than doctoral dissertation), 2) doctoral dissertation recommended for publication, 3) filed motion accepted as formally appropriate for grant in National Science Centre (Narodowe Centrum Nauki), National Humanities Development Programme (Narodowy Program Rozwoju Humanistyki), The National Centre of Research And Development (Narodowe Centrum Badań i Rozwoju) or in "Horizon 2020 - The EU Framework Programme for Research and Innovation". (2014–2020) as a project manager or - in some consortium projects – as a team leader or contractor with a contract of employment, or civil law contract or scholarship in the project financed by institutions mentioned above. 4) presenting a plan of research activities for the next 2 years. In the case of competitions, where the formal assessment stage is not specified the positive evaluation of the first stage is taken into account).

- 2. Formal evaluation of submitted proposals.
- 3. Call to provide additional or missing documents if necessary.
- 4. Selection of candidates for the interview stage.
- 5. Interviews for candidates who meet the formal requirements.
- 6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.
- 7. The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.
