- 2. Research plan (0-5 points);
- 3. Relevance of the subject matter and research interests to the scientific development of the Faculty (0-4 points);
- 4. Experience in obtaining and conducting research grants (0-2 points);
- 5. Experience and competence in teaching mathematics or computer science (0-4 points).

#### VIII) The selection process

- 1. Recruitment committee begins working no later than 14 days after the deadline for submission of documents.
- 2. Formal evaluation of submitted proposals.
- 3. Call to provide additional or missing documents if necessary.
- 4. Interviews with candidates who meet the formal requirements.
- 5. The chair of the recruitment committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.
