- Curriculum Vitae;
- Diplomas or certificates issued by colleges and universities attesting to education and degrees or titles held (in case of academic degrees obtained abroad - the documents must meet the equivalence criteria set out in Article 328 of the Act of 20 July 2018 Law on Higher Education and Science (Journal of Laws of 2024, item 1571 Polish: Dziennik Ustaw 2024 poz. 1571 t.j.);
- Information on research, teaching, and organizational achievements, including in particular:
  - a list of the candidate's publications, especially those demonstrating excellent knowledge of Roman law or ius commune;
  - information on research conducted as part of international cooperation in the field of Roman law or legal history;
  - information on grants obtained and applications submitted for research funding, specifying the type of grant and the nature of the involvement (principal investigator, main contributor);
  - documents confirming experience in editorial work; diplomas or awards for scientific research of internationally recognized prestige; elected membership in internationally recognized academic organizations or associations.

The Vice-Rector in charge of the School of Social Sciences at Adam Mickiewicz University in Poznań announces a competition for one position of assistant professor in the group of research staff at the Faculty of Law and Administration, in the Department of Roman Law, Legal Traditions, and Cultural Heritage Law.

## III) Requirments and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2024, item 1571, Article 113 as amended) and who meet the following requirements:

- 1. A doctoral degree (PhD) in legal sciences;
- 2. Excellent knowledge of Roman law or ius commune, documented by internationally recognized academic publications;
- 3. Publications in prestigious international journals or publishing houses;
- 4. Basic knowledge of digital humanities methods.

Candidates who do not have experience in leading or participating in research projects obtained through competitive funding or who do not have experience in conducting research in international collaboration in the field of Roman law or history of law will not be admitted to the interview stage.

#### VIII) The selection process

- 1. Competition committee begins working no later than 14 days after the deadline for submission of documents.
- 2. Formal evaluation of submitted proposals.
- 3. Call to provide additional or missing documents if necessary.
- 4. Selection of candidates for the interview stage.
- 5. Interviews for candidates who meet the formal requirements.
- 6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.
- The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.
