#### I) Determination of qualifications: (researcher profile) according to the Euraxess guidelines

- (R3) Established Researcher (researchers who have developed a level of independence)
- (R4) Leading Researcher (researchers leading their research area or field)

#### II) Job Offer description

Full-time university professor in a group of research-and-teaching staff at the Faculty of Mathematics and Computer Science of the Adam Mickiewicz University, Poznań.

#### III) Requirements and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2022, item 574, i.e. Article 113) and who meet the following requirements:

1. At least one of two conditions is met:
  - a. postdoctoral degree in mathematics or a related discipline;
  - b. doctoral degree in mathematics or related discipline and achievements that constitute a significant contribution to the development of science. These achievements should include at least one scientific monograph published by a prestigious scientific publishing house or a series of scientific articles published in prestigious scientific journals or in peer-reviewed materials from international conferences. These achievements cannot coincide with the basis for awarding the doctoral degree. An additional requirement is significant scientific activity carried out in cooperation with several universities or scientific institutions, preferably from more than one country. Teaching activity is also required.
2. Publication achievements adequate to the stage of a scientific career in mathematics or computer science discipline;

3. Motivation to work in science, independence, communication skills;
4. Motivation and teaching abilities;
5. Meeting the language requirements.

#### IV) Required languages

Language: English      Level: fluent (at least B2 level), allowing for writing scientific publications and delivering conference presentations

Language: Polish      Level: native or fluent, allowing the fulfillment of organizational and teaching duties or declaration to reach an adequate level of Polish within two years

#### V) Required research, teaching or mixed experience

2. Experience in teaching in the field of mathematics or computer science at the academic level.

#### VII) Eligibility criteria

**Detailed criteria for the evaluation of candidates in the thirist stage (the candidate must receive at least 10 points to be invited to the second stage):**

1. Value of scientific achievements and scope of research topics (0-5 points);
2. Experience in obtaining and conducting research grants (0-5 points);
3. Experience in teaching in the field of mathematics or computer science at the academic level (0-3 points);
4. Research plan (0-5 points).

**Detailed criteria for the evaluation of candidates in the second stage – after the lecture (the candidate must receive at least 5 points):**

1. Evaluation of the lecture and interview with the recruitment committee (0-5 points)
2. Relevance of the issues and research for the scientific development of the Faculty (0-5 points);

#### VIII) The selection process

1. Recruitment committee begins working no later than 14 days after the deadline for submission of documents.
2. Formal evaluation of submitted proposals.
3. Call to provide additional or missing documents if necessary.

4. Selection of candidates for the second stage, in which the selected candidates will give an open lecture and will have an interview with the recruitment committee.
5. The chair of the recruitment committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.
