II) Job offer description

The staff of the Department of Unique Languages at the Institute of Applied Linguistics at the Faculty of Modern Languages and Literatures do research in Modern Greek linguistics and literature, and offer courses in those fields to university students.

The candidate will be expected to do research, be active in publishing and obtaining research grants, and teach students (210 hours per academic year).

III) Requirments and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2023, item 742, i.e. Article 113, as amended) and who meet the following requirements:

- 1. Documented research activity in the discipline of linguistics (preferably Modern Greek linguistics and/or comparative Polish-Modern Greek linguistics).
- 2. International publications years in scientific journals last 4 years.
- 3. Documented management or/and participation or in scientific projects last 4 years.
- 4. Documented teaching experience as an academic teacher in philological or linguistic studies, especially in the following subjects: teaching Modern Greek, teaching a Modern Greek as LSP, cultural linguistics, comparative linguistics, or/and historical Indo-European linguistics with an emphasis on Greek Language.
- 5. Preferred level of native Greek (New Greek) level C2.
- 6. Good knowledge of English.
- 7. A knowledge of Polish is welcome.

VIII) The selection process

- 1. Competition committee begins working no later than 14 days after the deadline for submission of documents.
- 2. Formal evaluation of submitted proposals.
- 3. Call to provide additional or missing documents if necessary.
- 4. Selection of candidates for the interview stage.
- 5. Interviews for candidates who meet the formal requirements.
- 6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.
- 7. The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.
