Additionally, the successful candidate will be co-responsible, together with the principal investigator, for supervising a doctoral candidate working on the same project, and will be required to actively participate in regular lab meetings. Due to project requirements, the successful candidate will need to be based in Poznań, Poland.

2. Formal evaluation of submitted proposals.
3. Call to provide additional or missing documents if necessary.
4. Selection of candidates for the interview stage.
5. Interviews for candidates who meet the formal requirements.
6. The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.

IX) Prospects for professional development

The successful candidate will be able to pursue their own research agenda (as long as this will not undermine their work on the funded project). The research team will support them in preparing publications based on this research, as well as in preparing future grant applications. Conference funding will provide the successful candidate with networking opportunities.
