Call for Applications for a Three-Month Research Scholarship for a PhD candidate enrolled at a Polish higher education institution

Adam Mickiewicz University, Poznań, as a partner institution in the project financed by the Polish-German Foundation for Science, announces a call for applications for a three-month research scholarship for a PhD candidate enrolled at a Polish higher education institution. The scholarship period runs from 2 March 2026 to 31 May 2026. The scholarship amounts to the equivalent of EUR 1,200 per month (gross-to-gross amount subject to fiscal charges depending on the status of the scholarship holder, in accordance with Polish law). Permanent physical presence in Poznań is not required; remote work is permitted.

Application deadline: 20 February 2026

Eligibility criteria:

- 1) PhD student status at a Polish higher education institution throughout the entire scholarship period.
- 2) Master's degree in political science and administration, international relations, European studies, or related disciplines.
- 3) Documented experience in research on paradiplomacy (e.g. participation in research grants, doctoral dissertation project, bachelor's or master's thesis, published academic article, conference presentation).
- 4) Experience in the application of quantitative and qualitative research methods.
- 5) Fluency in English. Knowledge of German and/or Ukrainian will be considered an additional asset.

Duties of the scholarship holder:

- 1) Analysis of the political and institutional environment of change before and after 2022, i.e. state policy concepts and local government concepts as determinants of paradiplomacy, based on sources such as legal acts, funding and networking programmes, and political debates. The duties should be completed with the following outcomes:
 - a) co-authorship of a working report mapping structural changes in the political and institutional environment;
 - b) co-authorship of recommendations for work packages 4, 5, and 6 (change of discourse, change of actions, social change);
 - c) co-authorship of a scientific article for a peer-reviewed journal;
 - d) authorship of a chapter for the final publication of the project.
- 2) Active participation in the work of the research team, including other tasks assigned by the Polish project coordinator.

Application procedure:

Applicants are required to submit their application as a single PDF file containing:

- 1) Application letter with motivation (maximum 1 page);
- 2) Academic CV (maximum 2 pages);
- 3) List of publications or other academic achievements (maximum 2 pages);
- 4) Letter of recommendation (maximum 1 page) from the doctoral supervisor or another independent academic staff member (habilitated doctor or professor).

The organisers reserve the right to conduct online interviews with shortlisted candidates. Applications will be evaluated by a selection committee appointed by the Polish project coordinator, Prof. Jarosław Jańczak, PhD, DSc. Applications should be sent to paradyplomacja@amu.edu.pl by 20 February 2026. The results will be announced within seven days after the application deadline on the following websites: bip.amu.edu.pl and wnpid.amu.edu.pl.

Information Clause for Scholarship Applicants

Pursuant to Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation; Official Journal of the EU L 119/1 of 4 May 2016), we hereby inform that:
