

**Competition announcement  
for a PhD studentship  
within a SONATA BIS 12 project**

**Institution:** Faculty of Psychology and Cognitive Science, Adam Mickiewicz University

**Position:** PhD student

**Requirements:**

Essential:

- Master's degree in Psychology or related discipline (cognitive science, sociology, etc.);
- Interest in any area of cognitive psychology and in basic research;
- English language skills at a level enabling reading scientific literature and discussing research at conferences;
- Knowledge of and adherence to ethical rules governing experimental research;
- Willingness to apply to the Doctoral School of Social Sciences at the Adam Mickiewicz University for the 2024/25 academic year.

Desirable:

- Knowledge of software for programming and deployment of experiments (e.g., E-Prime, lab.js) or programming language/s (e.g., Python);
- Authorship or co-authorship of a reviewed publication;
- Authorship or co-authorship of presentation/s at esteemed scientific conferences.

**Task description:**

The PhD student will work as part of a team on the SONATA BIS project "The influence of external cues on metamemory judgments" (2022/46/E/HS6/00096) led by dr hab. Katarzyna Zawadzka (a brief description of the project can be found here:

<https://www.ncn.gov.pl/sites/default/files/listy-rankingowe/2022-06-15buti7za/streszczenia/566550-en.pdf>).

The PhD student will be responsible for running a series of experiments within the project. Their tasks will include:

- 1) Research planning, including literature reviews;
- 2) Preparing experimental procedures;
- 3) Conducting and coordinating studies;
- 4) Data analysis;

- 5) Preparing manuscripts under the supervision of senior team members;
- 6) Sharing research findings, including presenting the findings at scientific conferences (paid for from the project).

**Terms of employment:**

Studentship: 2,500 PLN/month (plus a PhD scholarship – see below) for 48 months

Project start date: October 2024

The studentship will be paid in monthly instalments, based on a contract between the university and the studentship holder.

Due to project requirements, as well as the requirement to complete doctoral training in the Doctoral School, the PhD student will be expected to move to Poznań, Poland.

**Additional information:**

Important: The studentship contract will be signed only if the candidate is accepted by the Doctoral School of Social Sciences at the Adam Mickiewicz University for commencement of studies in October 2024. The PhD student will then also receive an additional monthly doctoral studentship equalling 37% of the professorial salary – at present, 3,466.90 zł PLN (gross) – until the midterm assessment after the second year of studies, and 57% of the professorial salary – at present, 5,340.90 PLN (gross) – after the midterm assessment. The PhD student will be expected to complete their doctoral research under the supervision of the principal investigator.

Required documents:

- CV including: the topic of Master's thesis, information on active participation in research projects, conferences, workshops and training programmes, activity in student scientific societies, scholarships, awards, completed cognitive psychology courses together with grades;
- A brief description of research interests;
- Copies/scans of scientific publications;

- A statement confirming the willingness to apply for a PhD programme with a commencement date of October 2024, including the scientific discipline;
- A signed statement of consent to data processing as part of the recruitment process (which can be found at the end of this document).

The applications will be reviewed by a recruitment committee in accordance with the Regulations for Awarding Scientific Fellowships in Research Projects Funded by the National Science Centre. After reviewing the application documents, the committee will invite the highest ranked candidates to an online interview which will take place in the first half of July 2024.
