3. Motivation to work in science, independence, communication skills;
4. Meeting the language requirements.

VII) Eligibility criteria

1. Value of scientific achievements and scope of research topics (0-5 points);
2. Relevance of the subject matter and research interests to the scientific development of the Faculty (0-4 points);
3. Research plan (0-4 points);
4. Experience in obtaining, participating in or conducting research grants (0-2 points).

VIII) The selection process

1. Recruitment committee begins working no later than 14 days after the deadline for submission of documents.
2. Formal evaluation of submitted proposals.
3. Call to provide additional or missing documents if necessary.
4. Interviews with candidates who meet the formal requirements.
5. The chair of the recruitment committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.
