The job offer is addressed to people with a PhD in social sciences in the field of social communication and media studies. The person employed in this position will work in the Department of Social Communication of the Faculty of Political Science and Journalism of Adam Mickiewicz University. Employment is a chance to work in a very good team of scientists who will provide support in the field of research and teaching. The candidate will conduct teaching classes for up to 330 hours per year.

- Academic and teaching achievements in the fields of: media engagement, interaction and parasocial relationships, sexualization in media, media studies—particularly on popular culture and its messages, reality television, and social communication;
- Contributions to improving the quality of education and developing study programs and curricula;
- Proficiency in Polish sufficient to conduct academic classes;

- Proficiency in English sufficient to conduct academic classes;
- Good command of one of the official conference languages;
- Experience in obtaining research funding;
- Strong motivation for academic and teaching work.

- Obtained certificates;

- Participation in projects aimed at enhancing competencies in the field of social communication and media studies;
- Academic plans;
- Research interests;
- Conference activity, participation in workshops, summer schools, etc.;
- Experience in activities aimed at improving the quality of education and in developing study programs and curricula;
- Teaching experience;

VIII) The selection process

1. Competition committee begins working no later than 14 days after the deadline for submission of documents.
2. Formal evaluation of submitted proposals.
3. Call to provide additional or missing documents if necessary.
4. Selection of candidates for the interview stage.
5. Interviews for candidates who meet the formal requirements.
6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.
7. The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates.

IX) Prospects for professional development

A person employed as a senior lecturer will have the opportunity for professional and scientific development. An additional advantage of the job will be the opportunity to take part in the implementation of various scientific projects and obtain scientific degrees.
