II) Job Offer description

Position of assistant professor at the Faculty of Pedagogy and Fine Arts in Kalisz in the Department of Art Education, which conducts artistic/scientific activities, university teaching in the field of art (fine arts), involved in organizational and popularization activities in the parent organizational unit.

Adam Mickiewicz University will be the primary place of employment for the assistant professor. The employer expects research in the field of the discipline - *Fine Arts and conservation of works of art*; applying for scientific grants, publishing the results of artistic research, articles and monographs. Conducting workshops in the analog and digital photography studio using audiovisual tools. Carrying out teaching activities, including conducting art diplomas at first and second cycle studies, for a total of 210 teaching hours per year.

REQUIREMENTS:

- 1. Conducting artistic creativity, creative research, publicizing achievements in the country and abroad.
- 2. Obtaining external grants.
- 3. Artistic teaching 210 hours a year in: Photography (minimum 7 hours a week) and BA / MA seminars.
- 4. Organization of conferences, symposia, workshops, and open-air workshops.

PROFILE:

- 1. Doctorate in the discipline: fine arts and conservation of works of art.
- 2. Very good knowledge of the Polish language.
- 3. Good command of the English language.
- 4. Ability to cooperate in a team.

III) Requirments and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2023, item 742, Article 113 as amended) and who meet the following requirements:

- 1. Doctoral degree in the field of fine arts and competences for artistic work in the field of fine arts;
- 2. Organizational skills and experience in working with students, including the ability to activate them outside of class, incl. by participating in promotional campaigns at the University and outside;
- 3. Knowledge of the implementation of photographic techniques classic and digital, and experience in interdisciplinary work;
- 4. Ability to conduct independent exercises, workshops, plein-airs at 1st and 2nd degree studies and to conduct classes at courses or postgraduate studies;
- 5. Knowledge of the Polish language sufficient to enable teaching with students and communication in the scope of the required discipline in English.

- 1. Artistic achievements in the field of fine arts, especially in the field of classical and digital photography (documented participation in exhibitions, national and international competitions, awards and distinctions, etc.).
- 2. Scientific achievements in the field of fine arts, especially in photography (publications, participation in conferences, national and international symposia).
- 3. Teaching competences in the field of fine arts, especially in the field of photography (conducting classes, workshops, plein-airs, etc.).
- 4. Cooperation with the external environment (documented participation in projects and other artistic events, etc.).
- 5. Plans for further artistic and scientific development
- 6. Interview in Polish.

VIII) The selection process

- 1. Competition committee begins working no later than 14 days after the deadline for submission of documents.
- 2. Formal evaluation of submitted proposals.
- 3. Call to provide additional or missing documents if necessary.
- 4. Selection of candidates for the interview stage.
- 5. Interviews for candidates who meet the formal requirements.
- 6. The committee has the right to request external reviews of candidates' work or to ask candidates to conduct teaching assignments with an opportunity for student evaluation.
- 7. The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses. Submitted documents will be sent back to candidates along with the information.
