(UMO-2019/34/E/HS6/00164) (1) participation in data analysis and compilation of research results collected in three measurements in quantitative surveys; (2) participation in the final overall data analysis and compilation of the combined results of the quantitative and qualitative studies; (3) participation in the dissemination of the results of the quantitative studies and qualitative research in the form of scientific publications, popular science, conference papers; (4) participation in the implementation of the project's data available management plan. III) Requirments and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2024, item 1571; Polish: Dz. U. z 2024 poz. 1571 t.j.) and who meet the following requirements:

- 1. a doctoral degree in the social sciences in the discipline of psychology;
- 2. a doctoral degree obtained no earlier than January 1, 2018, and this period may be extended by the time spent during this period on long-term (more than 90 days) documented sickness benefits or rehabilitation benefits due to inability to work. In addition, the number of months spent on leave for the care and upbringing of children granted under the rules may be added to this period and upbringing of children granted under the terms of the Labor Code, and, in the case of women, 18 months for each child born or adopted, if this way of indicating breaks in the scientific career is more favorable;
- 3. the candidate's doctoral degree has not been conferred by the entity where the post-doc is planned to be employed;
- 4. the candidate is not a person for whom the project manager was a promoter or assistant promoter;
- 5. the candidate has not, in the last two years prior to being employed in the project has not been employed on the basis of an employment contract in the entity where the research project will be implemented;
- 6. having knowledge of social psychology and singlehood;
- 7. having knowledge of mixed research, combining qualitative research using interviews with quantitative research;
