II) Job Offer description

We seek a motivated associate for a post-doc at the Climate Change Ecology Research Unit, Faculty of Geographical and Geological Sciences of the University of Adam Mickiewicz, in the OPUS project financed by the National Science Center, Poland. The research is based on peat cores obtained from peatlands in Poland, Estonia and Norway. The successful candidate will be responsible for data analysis and article writing. Within the contract, successful candidates will be able to broaden their competencies in proxy analyses critical for peatland palaeoecology, particularly pollen, testate amoebae or non-pollen palynomorphs. We offer work in a friendly, dynamic and supportive environment.

Due to the unavailability of Siberian areas for research, the activities were moved to Europe – mainly Poland, Estonia and Norway.
