The uniform text of the Regulations of the Employee Benefit Fund of Adam Mickiewicz University, Poznań constituting an attachment hereto shall not cover:

1) § 2 (2) of the Order No 477/2015/2016 of the Rector of Adam Mickiewicz University, Poznań of 29 January 2016, which provides:

“2. The existing provisions of the Regulations shall apply to requests for a 50% reduced fare in 2016 referred to in § 9 (1)(9) of the Regulations”.

2) § 2 (2) of the Order No 144/2017/2018 of the Rector of Adam Mickiewicz University, Poznań of 19 October 2017, which provides:

“2. The provisions of § 1 (4) enter into force on 1 January 2018. In 2017, the persons listed in § 7 (1)(2–4) of the Regulations shall be paid the holiday bonus on the basis of applications submitted in 2017”.
