#### Competition for a scientific scholarship for a doctoral student

The competition aims to select a doctoral student-scholarship holder who will perform research tasks under the NCN project No. UMO-2019/34/E/HS6/00164 entitled. "Singlehood in terms of the theory of ambiguous loss: The relationship between living alone and mental health in the perspective of moderating and mediating functions of selected psychological factors," led by Dr. Katarzyna Adamczyk, Professor at Adam Mickiewicz University. ### **Requirements**

Only persons who meet the following qualification criteria can apply in the contest:

- 1. Master's degree in psychology;
- the status of a participant of doctoral studies (within the meaning of the Act of 27 July 2005 on Higher Education) or the status of a doctoral student at a doctoral school (within the meaning of the Act of 20 July 2018 Law on Higher Education and Science);
- 3. basic knowledge of singlehood and positive psychology;
- 4. intermediate knowledge of methodology, psychometrics, and statistics;
- 5. intermediate skills in conducting quantitative research;
- 6. intermediate knowledge and skills in conducting statistical analysis;
- **7.** intermediate knowledge and skills in creating online surveys and operation of the selected online survey platform;
- **8.** basic knowledge and skills in qualitative research, particularly of narrative psychology and narrative data analysis;
- **9.** experience in dissemination of research results in the form of scientific papers and conference presentations;
- **10.** experience in working on scientific projects.

Additional advantages: very good knowledge of English (spoken and written), regularity, reliability, punctuality, perseverance, enthusiasm for work, independence, high motivation to undertake research tasks, ability to work in the team.

# **Description of tasks:**

- 1. participation in conducting the analysis and compilation of data from the first measurement and to participate in disseminating the results of the first measurement and validation studies;
- **2.** participation in conducting the second and third measurements of the quantitative surveys;
- **3.** participation in conducting the analysis and compilation of data from the second and third measurements and involvement in the dissemination of the results obtained;
- **4.** participation in conducting the final overall data analysis and elaboration (also concerning the results of the earlier qualitative research) and involvement in disseminating the results obtained under the project.

### Conditions for the award of a scientific scholarship

The scholarship holder will be selected through a competition conducted following the Regulations for Awarding NCN Research Fellowships in Research Projects Funded by the National Science Center (Appendix to NCN Council Resolution No. 25/2019 of March 14, 2019).

The competition for an NCN research fellowship will be conducted by a fellowship committee chaired by the project leader. The commission will consider applications, taking into account their completeness and fulfillment of the conditions outlined in the competition announcement of the competition. The scholarship committee will evaluate applications on a

point scale, indicated in the Appendix to NCN Council Resolution No. 25/2019 of March 14, 2019. It will develop a ranking of candidates for the scholarship. When evaluating candidates, the scholarship committee will consider previous scientific achievements, achievements resulting from scientific research, and competence to carry out specific tasks in the research project.

# **Required documents**

- 1. a cover letter addressed to the project leadder justifying the desire to join the project;
- 2. a CV containing detailed information on the academic and research career, including information on publications, participation in research projects, conference presentations, and scientific and organizational achievements, along with an indication of the extent to which the candidate's past accomplishments and experience will allow them to carry out the tasks envisaged in the research project;
- **3.** a copy of the diploma confirming the acquisition of a master's degree;
- **4.** a certificate confirming the status of a participant in doctoral studies or the status of a doctoral student in a doctoral school;
- 5. copies of the first page of all publications;
- **6.** a description of the projects in which the candidate/candidate has participated (maximum two typed pages);
- **7.** letter of recommendation (optional)
- 8. consent for processing personal data (the content of consent below).

The required documents should be attached as PDF files. Incomplete applications, those that do not meet formal conditions, and those submitted after the deadline will not be considered.

Recruitment is a two-stage process and includes 1) evaluation of candidates' documentation and 2) an interview. Selected candidates contacted by e-mail will be invited to the interview. Candidates will be notified of the recruitment results by e-mail, and the results will also be published on the unit's website.
